(OVER) ATA: 5340 <u>COMPLIANCE TIME</u>: To coincide with the next annual Inspection or complete cycle event inspection but not to exceed one (1) calendar year from date of this Service Bulletin.

<u>PURPOSE</u>: Through the release of earlier service publications, Piper Aircraft has informed its customers of the availability of shoulder harness kits for installation in all Piper Models.

Over the years, Piper, along with the government, industry, and the public, has become increasingly aware that use of complete restraint systems (lap belt and shoulder harness) not only assists in secure positioning of the pilot and passengers during critical phases of flight and in turbulence, but also adds significantly to occupant safety.

While believing that most owners are aware of the benefits of shoulder harness and lap belt use, Piper emphasizes by the issuance of this Mandatory Service Bulletin that information developed during recent years indicates that such use can be a valuable contribution to the safe operation of your airplane.

Accordingly, Piper is issuing this Mandatory Service Bulletin and strongly urges you to install and use the complete restraint system of both seat belts and shoulder harnesses for all crew and passengers each time your aircraft is operated.

This Service Bulletin is the first of several which will address the entire line of Piper products regarding installation of shoulder harness restraints.

This Service Bulletin provides instructions and a "Serial Number Applicability Table" to help determine and facilitate installation of shoulder harness restraint systems for the affected model aircraft.

APPROVAL: The technical contents of this Service Bulletin have been approved by the F.A.A.

#### INSTRUCTIONS:

- 1. Visually inspect to determine if seat belts and shoulder harnesses are installed for every seat in your model aircraft. If seat belts and shoulder harness are installed, proceed with instruction 5. If only some or none of your seats are equipped with shoulder harness restraints continue with these instructions.
- 2. Refer to the "Serial Number Applicability Table" to determine which shoulder harness kit applies to what aircraft and which seat position.
- 3. Determine if the lap seat belt in your aircraft is of the type to accept the shoulder harness attachment. If not, refer to the appropriate Piper parts manual and order the lap seat belt as called out for shoulder harness installation. Some kits in this Service Bulletin do not include the lap seat belt.

### NOTE PA-32/34 AIRCRAFT

For customers with optional seventh seat installation, Piper recommends that this seat not be used. An adequate shoulder restraint is not available.

- 4. Upon completion of the shoulder harness restraint installation, Piper recommends that the owner/operator becomes familiar with the use of the new restraint system(s).
- 5. The owner/operator should as standard procedure, use the shoulder harness and lap belt restraint systems and should advise all passengers and crew to use their systems, providing instruction for use as necessary.
- 6. Upon completion of this Service Bulletin make a log book entry of compliance.

MATERIAL REQUIRED: Appropriate Kit(s) as called out on the "Serial Number Applicability Table".
