
- **COMPLIANCE TIME:** To coincide with next regularly scheduled maintenance event, but not to exceed the next one hundred (100) hours time in service.
- **APPROVAL:** The technical content of this Service Bulletin has been shown to comply with the applicable Federal Aviation Regulations and is FAA approved.

**PURPOSE:** It has been discovered that the above noted aircraft were delivered with tail cone fairing attachment clip nuts installed that did not incorporate a thread locking feature that prevents the fairing mounting screws from loosening and backing out. If the screws were to loosen and fall out, the displaced fairing may interfere with the operation of the horizontal stabilator.

### **INSTRUCTIONS:**

- Remove the 16 screws, P/N 415-378, (MS51957-45) (Figure 1, Item E) securing the tail cone fairings to the aft end of the fuselage. Remove the 10 screws, P/N 410-054,((MS24694-C5) (Figure 1, Item D) securing the upper tail cone fairing (Figure 1, Item A) to the lower tail cone fairing (Figure 1, Item B).
- Remove and replace the 26 clip nuts, P/N 477-640, (Figure 1, Item C) from the fuselage and the upper and lower tail cone farings, ensuring that the replacement clip nuts have a 'thread locking' feature.
- 3. Reassemble the upper and lower tail cone farings and re-install the tail cone fairing using the appropriate screws previously removed.
- 4. Make a logbook entry indicating compliance with this Service Bulletin.

**SUMMARY:** Applicable Factory Participation is limited to new aircraft in warranty at the time of compliance. Factory Participation will remain in effect for a period of time not to exceed 180 days from the date of this Service Bulletin.
