## MAINTENANCE ALERT

SUBJECT: IGNITION HARNESS ROUTING INSPECTION

MODELS AFFECTED: SERIAL NUMBERS AFFECTED:

PA-28-181 Archer III 2843001 and Up

**COMPLIANCE TIME:** To coincide with next regularly scheduled maintenance event, but not to exceed

the next one hundred (100) hours time in service. (For Warranty eligibility, see

the Summary section of this document.)

**APPROVAL:** The procedures specified in the instructions section have been shown to comply

with the applicable Federal Aviation Regulations and are FAA approved.

**PURPOSE:** It has been discovered that the ignition cables shown in Figure 1 are sometimes

improperly secured when they have been removed for maintenance. If these cables are improperly routed and secured upon re-installation, they may

interfere with the oil cooler.

This letter adds a strip of spiral wrap to provide additional protection for the

ignition cables if the spiral wrap is missing.

If the condition is left uncorrected it may cause damage to the ignition cables.

## **INSTRUCTIONS:**

- 1. Remove upper engine cowling. Check the ignition cables and clamp indicated in Figure 1. Ensure the cables do not contact or rub against the oil cooler.
- 2. If the ignition cables are interfering with the oil cooler or they are not properly routed, inspect for damage, reroute and secure correctly.
- 3. Check for the protective spiral wrap. If the spiral wrap is missing, install an eight (8) inch strip of spiral wrap around the ignition wires from the clamp toward the magneto.

NOTE: Clamp and attaching hardware part numbers may be found in the engine manufacturer's Parts Catalogs.

- 4. Install upper engine cowling.
- Make a logbook entry indicating compliance with this Service Letter.



**SUMMARY:** There is no Warranty eligibility on this service letter. Please contact your Factory Authorized Piper Service Facility to make arrangements for compliance with this Service Bulletin in accordance with the compliance time indicated.

the present owner/operator and notify the factory of address/ownership corrections. Changes should include aircraft model, serial number, current owner's name and

address.
